

## Ultimate JonnyPops Experience Reward Terms and Conditions

### 1. Overview

By submitting 10,000 Kind Deed Points to redeem the *Ultimate JonnyPops Experience* Kindness is Golden Reward (the "Reward"), you (the "Redeemer") agree to be bound by these Terms and Conditions. The *Ultimate JonnyPops Experience* is a magical, one-of-a-kind adventure to Minneapolis, Minnesota, for the Redeemer and up to three (3) guests. This includes making your very own JonnyPops flavor in the R&D Lab at the JonnyPops office, a memorable experience filled with fun, flavor, and kindness. You'll also receive boxes of your custom flavor to take home. Please read the following terms carefully before redeeming your Kind Deed Points for this Reward. If you do not agree with these terms and conditions, do not redeem your Kind Deed Points for this Reward. Capitalized terms used but not otherwise defined have the definition attributed to them in the JonnyPops® Kindness is Golden Rewards Program Terms and Conditions, which are incorporated herein by reference.

### 2. Reward Details

The Reward includes the following, provided to the Redeemer and up to three (3) guests:

- **Round-trip Flights:** Up to four (4) round-trip, economy flights to Minneapolis, Minnesota, from a major airport nearest to the Redeemer's residence. Flights will be included if the Redeemer's drive to the location exceeds four (4) hours. Travel dates will be determined by the Sponsor based on availability. The total value of the economy flights will be covered up to a maximum amount of [\$750] per person, for a total flight value of up to [\$3,000] for all travelers. The flights will be arranged by the Sponsor, and economy seating will be provided. Any additional flight costs, upgrades, or changes are the responsibility of the Redeemer.
- **Lodging:** A minimum of two (2) nights' stay for the Redeemer and up to three (3) guests at a hotel selected by the Sponsor in Minneapolis. The Sponsor will cover one (1) standard hotel room. Winner and each guest may be required to present a valid credit card at the hotel at the time of check-in.
- **The Ultimate JonnyPops Experience (the "Reward"):** A magical day spent at the JonnyPops Office in Minneapolis, where the Redeemer and their guests will create their own custom JonnyPops flavor in the R&D Lab. The flavor will not be sold in stores but the Redeemer will receive boxes of their unique flavor to take home.
- **Meal Stipends:** Reimbursement for meals of up to \$500 during the trip, subject to submission and verification of appropriate receipts.

Actual value may vary based on location and travel arrangements. The Reward is non-transferable. No cash alternative is available, except Sponsor reserves the right to substitute a reward for one of equal or greater value if the designated reward should become unavailable for any reason. The Reward must be used within twelve (12) months of the date Sponsor receives the applicable Order Form for the Reward, on one of the dates offered by Sponsor, no extensions will be granted. The Redeemer is not entitled to any difference between the approximate retail value and the actual value of the reward at the time the reward is awarded or redeemed.

### 3. Trip Details & Travel Restrictions

- **Location:** The Reward will take place in Minneapolis, Minnesota.
- **Length of Experience:** The Reward is guaranteed to be at least one (1) day and at least two (2) nights. Travel dates and experiences will be determined based on Sponsor availability and are subject to blackout dates.
- **No Manufacturing Plant Tour:** Please note that the Reward does not include a tour of the JonnyPops manufacturing plant.
- **Eligibility for Travel:** All travelers must have a valid passport or ID, as applicable, and any other required documentation to travel. Winner and each guest must comply with all applicable requirements and restrictions related to the Reward including, without limitation, applicable travel dates, travel documentation, reservation and confirmation procedures, and travel restrictions, including any health and safety protocols. Sponsor will not obtain or provide travel insurance or any other form of insurance.
- **Costs and Expenses:** Any cost and expense not specifically outlined in these Terms and Conditions, including but not limited to meals, beverages, gratuities, taxes, hotel incidentals, excursions, ground transportation, fees, surcharges, and service charges are the sole responsibility of the Redeemer and their guests. Sponsor is not liable for any expense incurred as a consequence of a flight cancellation/delay or any acts or omissions whatsoever by air carriers, hotel or other transportation companies.
- **Guests:** If a guest is a minor in his/her state of residence, one of the travel companions must be the winner's parent or legal guardian or provide appropriate parental permissions and releases. All guests must travel on the same itinerary and at the same time as the Redeemer.

### 4. Publicity Release
